



Grading & Land Alteration Permit Application

A Grading Permit is required within the city limits of the City of Benton if the following apply for work planned on any parcel:

Removal of more than 2 trees greater than 12 inch diameter, more than 6 trees less than 12 inches in diameter, or multiple small trees and/or brush removed from more than 10% of the lot, or any brush or trees within an easement or ROW on the lot or adjacent drainage way/channel/ditch, or if any Excavation or Grubbing work that will disturb soil is to be done, or any Placement of Fill and any grading or re-grading work is to be done. No wetlands or drainage channels can be disturbed unless USACE and/or ADEQ permits have been obtained and accompany this permit. An appropriate and Approved SWPPP and SWPPP Plan, final Grading & Drainage Plans, and Drainage Report are to accompany this application.
